The Author represents and warrants that he or she is the sole author of the Work and the owner of the copyright to all its contents and that he or she has not engaged in plagiarism and that the Work, if fiction, represents no real events or person(s) that in any way could be deemed libelous and the Author has the right to enter into this agreement.

The Right To Your Work

The Author acknowledges and agrees that Wasteland Press acquires no right to ownership to the Work under this agreement and assumes no responsibility for reviewing or correcting the content of the Work. The Author retains full rights to all related cover images and other book related files to Work and may use these files elsewhere. Upon request, Wasteland Press will provide all files to the Author at no charge.

Book Royalties

On all sales of printed copies of the Work, Wasteland Press will pay the Author a royalty equal to 25% of the payments actually received from sales of printed copies of Work, less any shipping and handling charges, sales and use taxes, and returns. Royalties will not be paid on copies provided or sold to the Author.

Indemnities

The Author agrees to indemnify and hold harmless Wasteland Press and its employees from any and all manner of claims, liabilities, damages, losses, expenses (including attorney’s fees), awards, judgments resulting from claims of third parties regarding ownership, plagiarism, privacy violations, copyright infringement, and similar claims arising from publication of Work.

Disclosure of Royalties

Royalty checks and royalty reports are generated every quarter (March–June–September–December of each fiscal year). If sales are recorded, royalty checks will be mailed to the Author the month after the quarter has expired. If no sales are recorded, The Author understands that he or she will not receive a royalty check or royalty report. The Author also understands that royalty reports are available at any time, regardless of whether there have been sales or not, and can be requested by e-mailing webmaster@wastelandpress.net.

Shipping and Handling

The Author agrees to indemnify and hold harmless Wasteland Press and its employees from any and all manner of claims, liabilities, damages, losses, expenses (including attorney's fees), awards, judgments resulting from damage in shipping or usage of any delivery service deemed fit by Wasteland Press. However, the Author may choose to insure their package in transit of delivery by paying an additional fee of \$12.00 to cover the cost of their original investment. In such occurrence, all fees shall be refunded within the period of 30 working days. This fee is only required for the Basic Plan service. All other publishing plans have the \$12.00 fee incorporated in the price of each publishing plan due to Wasteland Press.

Terms and Exclusivity

The Author retains the copyright for this Work and may choose to enter into other publishing agreements. Either party has the option to terminate the Agreement at any time, with or without cause. If the Author prior to publication terminates the Agreement, the Author is responsible for payment of pre publication services, which is 30% of publication fee and can be no greater than \$999.00. If the Agreement is terminated by Wasteland Press and no breach of Agreement has occurred, all publication fees will be refunded in full. If the Agreement is terminated by Wasteland Press due to breach of Agreement by the Author, no fees shall be refunded. If the agreement is terminated by Wasteland Press or the Author after publication has taken place, then no refund will be due to the Author.

Worldwide Distribution

The Author understands and gives permission for Wasteland Press, Lightning Source Inc., Ingram Book Group, and any other distributor on behalf of Wasteland Press to distribute and promote the Author's Work worldwide. The Author also understands that his or her title will be fully returnable by bookstores, through the above mentioned companies for a period of one year at no extra charge. Thereafter, Wasteland Press will require a fee paid by the author in the amount of \$25.00 per year in order for Wasteland Press to continue distributing the Author's Work through the above mentioned distributors. The Author also understands if his or her contract is terminated, whether by Wasteland Press or by his or her own will, that it may take up to three (3) month for the Author's Work to be removed from the database of Wasteland Press, Lightning Source Inc., Ingram Book Group, and any other distributor utilized by Wasteland Press.
